## 1. WORK TO BE DONE

## 2. DRUGS AND MEDICATIONS

I understand that antibiotics and analgesics and other medications can cause allergic reactions causing redness and swelling of tissues, pain, itching vomiting, and/or anaphalactic shock.

## 3. CHANGES IN TREATMENT PLAN

I understand that during treatment it may be necessary to change or add procedures because of conditions found while working on the teeth that were not discovered during examination. For example, root canal therapy following routine restorative procedures. I give my permission to the Dentist to make any/all changes and additions as necessary.

## 4. REMOVAL OF TEETH

Alternatives to removal have been explained to me (root canal therapy, crowns, and periodontal surgery, etc.) and I authorize the Dentist to remove the following teeth \_\_\_\_\_ and any others necessary for reasons in paragraph # 3. I understand removing teeth does not always remove all the infection, if present, and it may be necessary to have further treatment. I understand the risks involved in having teeth removed, some of which are pain, swelling, spread of infection, dry socket, loss of feeling in my teeth, lips, tongue and surrounding tissue (Parasthesia) that can last for an indefinite period of time or fractured jaw. I understand I may need further treatment by a specialist if treatment is uncompleted or if complications arise during or following treatment, the cost of which is my responsibility. ## 5. CROWNS, BRIDGES AND CAPS

I understand that sometimes it is not possible to match the color of natural teeth exactly with artificial teeth. I further understand that I may be wearing temporary crowns, which may come off easily and that I must be careful to ensure that they are kept on until the definitive crowns are delivered. I realize the final opportunity to make changes in ny new crown, bridge, or cap (including shape, fit, size and color) will be before cementation. It is also my responsibility to return for final cementation within 30 days from tooth preparation. Excessive delays may allow for tooth movement. This may necessitate a remake of the crown, bridge, or cap at full fee. I understand there will be additional charges for remakes due to my delaying final cementation. (Initials \_\_\_\_\_)

## 6. ENDODONTIC TREATMENT (ROOT CANAL)

I realize there is no guarantee that root canal treatment will save my tooth, and that complications can occur from the treatment, and that occasionally root canal filling material may extend through the root which does not necessarily effect the success of the treatment. I understand that occasionally additional surgical procedures may be necessary following root canal treatment (apicoectomy), completion of RCT treatment or treatment for removal of instrumentation all would be completed by a specialist. All services provided by specialist carry additional fees and are the patient's responsibility. I understand that the tooth may be lost despite all effort to save it. Damage to existing restoration from having to access the root can occur if tooth has an existing filling, crown, or bridge. (Initials \_\_\_\_\_)

## 7. PERIODONTAL LOSS (TISSUE & BONE)

I understand that I have a serious condition, causing gum inflammation, bone loss or loss of supporting tissues that can lead to the loss of my teeth. Alternative treatment plans have been explained to me, including gum surgery, replacements and/or extractions. I understand that undertaking any dental procedures may have a future adverse effect on my periodontal condition. (Initials \_\_\_\_\_)

## 8. FILLINGS

I understand that care must be exercised in chewing on fillings especially during the first 24 hours to avoid breakage. I understand that a more extensive filling than originally diagnosed may be required due to additional decay. I understand that significant sensitivity is a common after effect of a newly placed filling due to the removal of natural tooth structure. (Initials \_\_\_\_\_)

## 9. DENTURES

I understand the wearing of dentures is difficult. Sore spots, altered speech, and difficulty in eating are common problems. Immediate dentures (placement of denture immediately after extractions) may be painful. Full and Partial denture may require considerable adjusting and several relines. A permanent reline will be needed later. This is not included in the denture fee. I understand that is my responsibility to return for delivery of the dentures. I understand that failures to keep my delivery appointment may result in poorly fitted dentures. If a remake is required due to my delays of more than 30 days, there will be additional charges which the patient is responsible to pay. (Initials \_\_\_\_\_)

I understand that dentistry is not an exact science and that therefore reputable practitioners cannot properly guarantee results. I acknowledged that no guarantee or assurance has been made by anyone regarding the dental treatment which I have requested and authorized. I understand that each Dentist is an individual practitioner and is individually responsible for the dental care rendered to me. I also understand that no other Dentist nor Dental Arts of Coronado Avenue is responsible for my dental treatment.

I hereby authorize any of the doctors or dental auxiliaries of Dental Arts of Coronado Avenue to proceed with and perform the dental restorations and treatments as explained to me. I understand that this cost is only an estimate and subject to modification depending on unforeseen or undiagnosable circumstances that may arise during the course of treatment. I understand that regardless of any dental insurance coverage I may have, I am responsible for payment of dental fees. I agree to pay any attorney's fees, collecting fees, or court costs that may be incurred to satisfy this obligation.

I CERTIFY THAT I HAVE READ AND FULLY UNDERSTAND THE ABOVE CONSENT TO DENTAL TREATMENT AND THAT THE EXPLANATIONS THEREIN REFERRED TO WERE MADE. ANYTHING I DID NOT UNDERSTAND HAS BEEN EXPLAINED TO ME.
